

# 2008 North Alabama Trail Riders Association (NATRA) Rules and Regulations

The member agrees to abide by all of the rules set forth below, in addition to the NATRA bylaws, and respect the extreme importance of safety.

1. Each year permit holders will be issued colored stickers to be worn on the back of member helmets for easy identification. A similar but different sticker will be provided for each ORV to be placed on the front.
2. **New for 2008: Member ID card must be with the member at all times on NATRA property.** Minors will be issued stickers and membership ID cards same as any other member. Minors must be accompanied by a permit holding adult.
3. **A HELMET MUST BE WORN AT ALL TIMES WHILE RIDING.** Federal and State law doesn't apply, this condition is dictated by landlord and insurance company.
4. Guest rules will be strictly enforced. One guest at a time, no more than 2 per year, Guests get only 2 visits total, except those living outside a 150 mile radius. If your guest joins NATRA then your guest count resets.
5. No trucks, jeeps, sand buggies or any vehicle over 56 inches wide may be used on the trails. Some trails are reserved for single track vehicles (motorcycles) less than 34 inches wide.
6. Permit holders will report any violations to a NATRA officer. May advise the violator, but please do not take enforcement upon yourself.
7. NO ALCOHOL, NO DRUGS, NO LOUD MUFFLERS... Behave yourself, we are a family oriented club.
8. Anyone caught littering will forfeit all riding and use rights. No litter may be buried on the property for any reason, pack it in, pack it out. No open fires on the ground.
9. The gravel roads are for emergencies (medical, mechanical, etc.) and have a 20 MPH speed limit.
10. No two-up riding except for emergencies unless the vehicle is designed to carry two people.
11. Trails are clearly marked for the direction of travel (**ONE WAY ONLY**) and for safety reasons **MUST** be ridden in that direction. **ALWAYS**, not just races.
12. Family membership is only intended for a family unit living at a single residence. **Adult children (19+ year olds are adults) require a separate membership.** Grandparents with grandchildren (and other special cases) may contact the president for possible exemption.

**Any permit holder found in violation of any of the rules and regulations will forfeit all riding and use privileges and monies.**

## **THIS IS A RELEASE WAIVER AND RELEASE FROM LIABILITY**

The undersigned expressly acknowledge and agree that the activities or event are very dangerous and involve the risk of serious injury and/or death and/or property damage.

For and in consideration of being permitted to ride motorcycles/ATVs or have access to lands commonly known as the "Westpoint" property in Lawrence County, each member, for himself, personal representatives, heirs, or assigns: Hereby Releases, Waives, Discharges and Covenants Not to Sue the Landowner, the Landowners Lesser, North Alabama Trail Riders Association, Inc., the Landowners agents in whatever capacity, from all loss or damage, on account of injury or death to person or property of the undersigned while on the Landowner's property and each of the undersigned expressly agrees that this Release, Waiver and Covenant not to sue is intended to be as broad and inclusive as is permitted by the Law of Tennessee and if any portion is held invalid, the balance shall continue in full legal force and effect.

Each of the members warrants the following statements are true and correct and understands that the Landowner and his Lesser and / or Agents in whatever capacity, have relied on them, in entering into the foregoing Release, Waiver and Covenant Not to Sue Agreement in issuing the undersigned a permit.

1. No Oral representations or inducements apart from the foregoing written agreement have been made.
2. He/she assumes full responsibility and risk of death or injury to person or property due to negligence of the Landowner, the Landowner Lesser or their Agents while on the Landowner's property.
3. HE/SHE HAS READ AND VOLUNTARILY AGREED TO THIS RELEASE AND WAIVER OF LIABILITY.

Each designated legal guardian for designated minor(s) agrees to indemnify and save and hold harmless "Releasees" and each of them from any loss, liability, damage or cost they may incur due to the presence of the said minor in or upon the Restricted Area caused by the negligence of "Releasees" or otherwise.

Designated legal guardian(s) expressly acknowledge and agree that said minor(s) will follow the rules set forth by NATRA for use of the Restricted Area. The undersigned parents or legal guardians have read, fully understand what it means, and voluntarily sign the membership application form.
